Permission to leave campus during lunch is a **PRIVILEGE** that may be **REVOKED** by an administrator for any of the following reasons:

- 1. A repetition of **tardiness** to the class immediately following the lunch period.
- Any truancy, suspension, or accumulation of 15 cumulative tardies. 2.
- 3. Failure to carry I.D. at all times and to respectfully present student I.D. when called upon to do so.
- 4. Presence at another school without permission while off-campus.
- 5. Using exits **OTHER** than the lower east doors and the main entrance.
- Any misconduct of the student. 6.
- Going off-campus any period other than lunch. 7.
- Not returning to classes or free period after lunch, including. In the case of illness, students must see the nurse. 8.
- 9. Returning to school and bringing a jacket to class (Jackets must be put in locker).

Parents may revoke off-campus permission during lunch at any time by contacting the student's administrator at (847)755-5619.

Any change in a student's status in regard to off-campus permission will require that a new I.D. card be issued at a cost of \$3.00.
