Fremd Student Parking Contract

Parking Rules

Parking space is **very limited** at Fremd. Your compliance with the following regulations is required. All motor vehicles require a permit. Permits are only valid if issued from the school.

1. You will lose your parking privileges and be subject to school disciplinary action and/or possible citation, arrest or TOWING AT YOUR EXPENSE if:
 - a. You drive in a careless or dangerous manner. You fail to report an accident or damage to another vehicle or property.
 - b. You park in non-designated areas such as no parking zones, walkways, staff lots, aisles, over or outside of yellow lines or visitor parking.
 - c. Your parking tag is not on display as designated below.
 - d. You possess and/or use alcoholic beverages, tobacco products, weapons, and for drugs in or about the vehicle.
 - e. You sell, copy or allow some to copy your parking permit. You possess or display a lost or stolen parking tag that is not registered to you.
 - f. Parking in the school parking lot without a permit will subject you to ticketing and/or towing at owner's expense.
2. Parents may revoke their child's parking permission at any time by notifying an administrator or the police consultant (fees forfeited for the current semester).
3. Students may park only in the east parking lot (Quentin Road and Illinois Avenue) in the student-designated areas. A map is located inside the discipline office. Parking in staff areas could result in possible citation.
4. You must display your parking permit on the rear view mirror of the front windshield. Jeep or convertibles may tape the permit just about the rear view mirror. The permit must be displayed so that the information on the permit can be read. Failure to do so could result in a citation.
5. The student parking permit is non-transferable. Do not put your name in the lottery if you will not be able to use the permit should your name get selected. Permits may NOT be sold. Vehicles in the lot must be the registered vehicle on file with Fremd High School. Unregistered vehicles may lose the parking permit.
6. Vehicles parked in the school parking lot are subject to search at any time by the school administration and/or the local police department.
7. Only students with valid parking permit may park on campus.
8. Students may not loiter, smoke tobacco, use chewing tobacco, or electronic cigarettes in vehicles on school property.
9. Fremd High School and District 211 are not liable for any damage, injury or death that may occur as a result of a person driving to school or parking on school property.
10. Students who use any vehicles to violate any school regulation, village ordinance, state law or federal law shall lose their school driving privileges.
11. **IMPORTANT: NO REFUNDS OR REPLACEMENTS** We will NOT replace lost or stolen parking permits. If the permit is mutilated or unusable it may be brought to the police consultant for a replacement if the entire permit is presented. We will not issue a refund for the current semester.
12. Students who withdraw from school must surrender their parking permit and forfeit fees for the current semester before transcripts will be issued.
13. Students enrolled in a work program course or a credit course for which D211 does not provide transportation are eligible to receive a parking permit at a cost of \$75 per semester. An application must be completed and submitted. Students must abide by the same rules outlined in this contract.
14. In order to accommodate as many parking applications as possible, students will only be provided one semester of parking through lottery.
15. To keep your permit secure, lock your vehicle at all times. Fremd will not replace lost or stolen permits.
16. The opportunity to purchase and use a parking permit on campus is a privilege. A student's pass may be revoked with no refund for attendance and discipline reasons.
17. Please note that students that park off campus in unauthorized areas, including Hunting Ridge Elementary School, are subject to ticketing and towing by the village of Palatine.
18. *Village of Palatine Ordinance #18-42: The Village of Palatine Ordinance #18-42 require that vehicles owned or leased by a resident, or that are principally garaged within the Village of Palatine must display a current vehicle sticker. Palatine Police Officers may Conduct Village Vehicle Sticker enforcement in school parking lots. All violators will be required to pay a penalty of \$40 in addition to the \$50 cost of the vehicle sticker or face a court appearance.*

Parking Rules Reminders

Students can only park in the area designated for student parking. Student parking stalls are marked with **yellow** lines. All stalls marked with white lines are for staff only. Any student who parks in staff parking could be ticketed. Repeat parking tickets could result in the vehicle being towed. **Use the map on the back of this page for more information about where to park.**

1. *Parking permits must be displayed by the student who was granted the pass from the Discipline office, the permit must be valid, and the permit must be visible. Do not park in the parking lot with an expired permit as this may jeopardize parking privileges in the future.
2. *For the safety of everyone, you must follow the arrows that are displayed on the front side of this map and painted in the parking lot. Do not cut across any spaces or go the wrong way down the parking aisles.
3. *A violation of the parking rules provided to you at sign up, on the website or those included in the 2020-2021 FHS Parking Contract could result in a conference with our School Resource Officer, a ticket from the Palatine Police Department, and/or the loss of parking privileges without a refund.
