# Citizens' Petitions and Appearances

David Burke addressed the Board thanking them for the quality of education his children received from District 211 and Schaumburg High School; and involving his gratitude to Schaumburg High School Principal Tim Little for his leadership, Schaumburg High School Student Services Director Yassi Delgado for her academic guidance, Schaumburg High School Music Department Chair and Band Director Vincent Inendino for his commitment to student development and mentoring to students, and the many special Schaumburg High School teachers.

#### Joseph Scanlon – VFW Post 1337

President Burke introduced Veterans of Foreign Wars (VFW) Post 1337 Commander Joseph Scanlon. Commander Scanlon presented the Board a donation to District 211 on behalf of Palatine High School graduate Aidan Busch who was selected as the Illinois winner in the 2016-2017 VFW Voice of Democracy Audio-Essay competition.

# <u>Public Hearing on the Proposal to Contract with a Commercial Driver Training School for Behind-the-Wheel Services for Driver Education and Recommendation to Contract Behind-the-Wheel Services for Driver Education</u>

Mr. Hinshaw made a motion, seconded by Mr. Yung, that the Board of Education open the public hearing required by Section 27-24.2 of the Illinois School Code on the proposal to contract with Top Driver commercial driver training school to provide behind-the-wheel services for driver education training to School District students. The public hearing opened at 7:56 p.m.

President Burke asked if there was anyone present who wished to comment on the Board contracting with a commercial driver training school for driver education.

Scott Lilley addressed the Board regarding the time provided to view the contract with the commercial driver education training school, outsourcing coursework to a third-party vendor and the accountability and oversight of coursework, the use of taxpayer monies and educational funds for the contract with the commercial driver training school, the use of the District 211 maintenance staff during

afterschool and weekend hours for the vendor, the storage of and signage on the vehicles on District 211 properties, the promotion of a private entity within the community, security and safety concerns involving outside people coming into school buildings on evenings and weekends; and getting input from all stakeholders involved before making a decision involving a third-party curriculum vendor.

Mrs. Klimkowicz made a motion, seconded by Mr. Rosenblum, that the Board of Education authorize the Superintendent or designee to enter into a contract in a form approved by the Superintendent and the Board's attorney with Top Driver to provide behind-the-wheel instructional services to District 211 students enrolled in a District 211 driver education course for the 2018-2019 and 2019-2020 school years.

Mr. Dombrowski addressed some of the concerns raised by Mr. Lilley. Afterwards, Superintendent Cates made the made the following comments:

"Our charge is to create the most benefit possible for our students while optimizing our resources." This initiative of securing third-party services to deliver behind-the-wheel driver education services is one important part of our overall primary interest of providing a four-year curriculum of student wellness. Driver education is a costly and labor-intensive program. Through the model we are presenting to you, we are utilizing savings and efficiencies totaling more than \$500,000 annually so that we can continue to provide safe and professional driver education training while also, and importantly, delivering a student wellness program that integrates health and fitness topics throughout all four years of high school. In order to create smaller class sizes to deliver an excellent wellness curriculum, we needed to identify efficiencies. Our teachers will continue to teach the classroom instruction for driver education and we are recommending that we utilize the professional driver education services of Top Driver to deliver the behind-the-wheel instruction. Through savings and greater efficiency, we will then be able to redeploy these teachers and resources toward student wellness. Department leaders from the physical education and health departments have devised a new curriculum model centered on wellness that students can use throughout their lives. By re-envisioning our health and physical education courses into a student wellness model, we can address meaningful development topics over the span of the four high school years. These critical health topics have historically been covered in a semester or during several weeks of summer school. In today's world, students need to know important health and wellness topics as soon as possible, and the new model will deliver this information as soon as students arrive in ninth grade. Everyone has been excited about a student wellness approach that will span all four years. Wellness is one of the five key components of the new Student Readiness Plan that we will provide every student on their iPad device to start the next school year. In just a few minutes, we will preview the plan for you. Two-thirds of our students already take driver education from private firms and by working together with our faculty, leaders from multiple departments, and the professional staff from Top Driver, we have been able to make important changes that will benefit students. Students, parents, and staff members have co"

# **Presentation: Business Pathways**

#### **Student Readiness Plan**

"For nearly two years, we have been working on a comprehensive project called the Student Readiness Plan. It has involved many people from the student services department. It has included many students, parents, and staff members. We piloted the readiness plan with 500 students. The leadership that has been working on this project, Mr. Mark Kovack and Dr. Lisa Small, and many people from the student services department, have done an excellent job. We are very pleased to share with you in just a few minutes our initial presentation about the readiness plan."

Dr. Cates reintroduced Dr. Small, who presented the promotional video of the Student Readiness Plan (SRP) that was created to help build awareness and interest in the plan that will be released to students and parents in the coming days as the District prepares for the full-scale launch of the SRP in the fall with all students. Associate Superintendent for Student Services Mark Kovack, Dr. Small, and Superintendent Cates answered Board members' questions.
