National Merit Scholars

Dr. Judith Campbell, Superintendent of Schools introduced Assistant Superintendent for Curriculum and Instruction Joshua Schumacher. Mr. Schumacher gave the following introduction:

“Good evening members of the Board of Education, Dr. Campbell, administrators, parents, and students.

For more than six decades, the National Merit Scholarship Program has recognized the nation's most academically accomplished students, those whose curiosity, determination, and commitment to excellence distinguish them as leaders among their peers.

This evening, it is my honor to introduce members of the District 211 Class of 2026 who have earned recognition as National Merit Semifinalists.

Each year, more than 1.6 million high school juniors across the country take the Preliminary SAT, or PSAT. From that extraordinary group, only about 16,000 students nationwide, roughly the top one percent of all test takers, achieve Semifinalist status. To put that in perspective, these 29 students represent not just the top of their class, but the top academic performers in the entire United States.

Reaching this level requires an exceptional combination of intellect, focus, and perseverance. It also reflects years of curiosity, discipline, and a deep love of learning; qualities that will serve these students well beyond high school.

In District 211, we celebrate not only their achievement, but also the people who have helped them reach it. Behind each of these scholars stands a network of support; parents, guardians, teachers, and mentors who have nurtured their curiosity, encouraged their effort, and modeled the value of persistence. To the parents who are with us tonight: we recognize and thank you for the countless hours you have spent guiding, listening, and cheering from the sidelines. This recognition belongs to you as well.

To honor these achievements, each student will receive the District 211 Robert Creek Excellence Award, named for longtime Board of Education President Robert Creek, whose 20 years of service, 19 as president, exemplified an unwavering belief in the power of education and the pursuit of excellence.

As I read each student's name, I also invite their parents to stand and be recognized for the encouragement and support they have provided throughout their child's academic journey.

As you can imagine, our students are deeply involved in their schools and communities, and a few are unable to be with us this evening. We are proud of each one of them for this extraordinary accomplishment.

Highest Possible Composite Score on the American College Testing (ACT) Exam

Dr. Judith Campbell, Superintendent of Schools reintroduced Assistant Superintendent for Curriculum and Instruction Joshua Schumacher. Mr. Schumacher gave the following introduction:

“Good evening members of the Board of Education, Dr. Campbell, administrators, parents, and students.

It is my privilege this evening to recognize an exceptional group of students from the District 211 Class of 2026 who have achieved one of the rarest academic distinctions in the nation; a perfect composite score of 36 on the ACT.

Each year, more than 1.4 million students across the United States take the ACT as part of the college admissions process. Of those test takers, fewer than one-tenth of one percent earn a perfect score. To achieve a 36 requires extraordinary ability, focus, and persistence; mastery across English, mathematics, reading, science, writing and the composure to demonstrate that excellence in a single sitting.

These students represent the very best of what it means to be a District 211 scholar; inquisitive, disciplined, and deeply motivated to reach their fullest potential.

We also want to take a moment to honor the parents and guardians who have supported these students along the way. Behind every perfect score is a foundation of encouragement; families who value education, model perseverance, and provide the balance and belief that allow young people to thrive. To the parents who are with us tonight, thank you for your partnership, your patience, and your unwavering support. You share in this accomplishment.

To commemorate this achievement, each student will receive the District 211 Medallion, which demonstrates excellence in a milestone achievement during their four years in high school. The 28 students invited to be honored tonight will join the previous list of 176 District 211 students who have earned a perfect score on the ACT.

As I read each student's name, I invite their parents to stand and be recognized for the role they've played in supporting their child's educational journey.

**RESOLUTION
AUTHORIZING INTERVENTION
IN PROCEEDINGS BEFORE THE STATE OF ILLINOIS
PROPERTY TAX APPEAL BOARD**

WHEREAS, the owner of a certain parcel of real property located within the corporate boundaries of Township High School District 211, Cook County, Illinois, has filed an appeal of the assessment of this parcel of real property with the State of Illinois Property Tax Appeal Board (the “PTAB”); and

WHEREAS, this appeal seeks a reduction in the assessed value of the parcel that is the subject of the appeal; and

WHEREAS, in such circumstances a taxing district has the right to intervene in the proceeding before the PTAB in order to protect its revenue interest in the assessed valuation of the parcel.
