### Illinois High School Gymnastics Coaches Hall of Fame Inductee

"Michelle Calish, now a counselor at Palatine High School, began coaching gymnastics at Conant High School as an assistant coach in 1995. In 1999, she took over as the Cougars head girls gymnastics coach. She coached the girls team for eight years, putting together a very impressive regular season record of 52 wins with only 13 losses. With Michelle at the helm, the Cougars girls gymnastics team claimed six regional titles, four sectional titles, had more than 30 state qualifiers, and made five state championship appearances. In those five state championship appearances, Michelle's teams finished third once, second twice, and were crowned Illinois High School Association state champions in 2006. This year, Michelle was inducted into the Illinois High School Gymnastics Coaches Association Hall of Fame.

Michelle, congratulations for this outstanding honor, and thank you for all you have done and continue to do throughout High School District 211."

### **Illinois Wrestling Coaches and Officials Association Hall of Fame Inductee**

Superintendent Cates made the following comments:

"John Kane began coaching wrestling at Conant High School in 1991, starting as an assistant coach under Hall of Fame Coach Jim Cartwright. Nine years later in 2000, John took over as the Cougar's head coach, a position he held until being named athletic director in 2008. During his time with the wrestling program, John coached 51 state qualifiers, 18 state place winners, and five state champions. John's team record as a head coach was 111 wins, 61 losses, and one tie. Under his leadership, the Cougars won three Mid-Suburban League Championships, four regional championships, and one sectional championship, and three of John's teams placed among the top four in the state. This year, John was inducted into the Illinois Wrestling Coaches and Officials Association Hall of Fame.

Congratulations, John, on this outstanding recognition, and thank you for all you have done for Conant High School and District 211 throughout the years."
