Cardiac Screening – Ruth Jensen

Superintendent Cates introduced community member Ruth Jensen, president of Joshua Jared Hardy Charities, and made the following comments:

"Ruth Jensen is an advocate for student wellness within our community and president of the Joshua Jared Hardy Charities, named in honor of her son who was a Fremd High School graduate and a passionate runner. Ruth has dedicated tireless efforts to inform, raise funds, and help students identify the risk of a genetic heart condition known as Hypertrophic Cardiomyopathy, which is the leading cause of cardiac death for people under the age of 30. Ruth's mission is literally to help save students' lives.

Ruth organization hosts and raises funds through the Hoofin' 4 Hardy Run each year in the fall. Ruth organized and funded electrocardiogram screenings to be available to any student in District 211. The screenings are conducted by the organization Young Hearts 4 Life. More than 3,800 District 211 students at three high schools have been screened completely free of charge to identify Hypertrophic Cardiomyopathy. Because of Ruth's efforts, the students in our remaining high schools will all have the opportunity to be screened. It is common that we receive notes and messages of appreciation thanking us for providing this important opportunity to our students through Ruth's work.

Ruth, your generosity, selflessness, and service to our students is one without measure. On behalf of the Board of Education and the District 211 community, I want to thank you for your tremendous work for our students and their well-being."

President Pro Tempore LeFevre presented a certificate to Mrs. Jensen for contributing funds raised by the Joshua Jared Hardy Charities to provide free electrocardiogram screenings for High School District 211 students and for organizing the screenings for the students with the Young Hearts 4 Life organization.
