#### **Military Recognition**

Superintendent Cates made the following comments:

Sergeant Rivera is a 2007 Conant High School graduate and is currently serving in the Marine Corps. Superintendent Cates made the following comments:

The ACT is taken by nearly 60 percent of America's college-bound students. The highest possible composite score is 36, which is achieved by approximately one percent of students taking the exam. Last year, in the State of Illinois' Class of 2014, just 184 students earned a composite score of 36.
