He's been inducted into the Illinois Track and Cross Country Coaches Association Hall of Fame and has served as the organization's president from 2003-2005, co-clinic director from 2006-2014, and is currently serving as secretary.

Congratulations Jim, on behalf of the Board of Education, for this outstanding and well-deserved honor, and thank you for your dedication to Fremd High School and your student-athletes.

Fremd High School Physical Education Teacher and Head Boys Soccer Coach Steve Keller has been named the Coach of the Year by the Illinois High School Soccer Coaches Association. This distinction recognized Coach Keller not only for his team's success this past season, but also for his leadership, dedication, and commitment to his student-athletes and the sport.

Steve has been with District 211 since 1998, coaching boys soccer for 17 years. During that time, his overall record is 225 wins, 127 losses, and 62 ties, including a 20-6-1 record this past season, good for third-place in the state. This was the second time one of Steve's teams finished third in the state, to go along with three fourth-place finishes, and one elite eight appearance. Steve also has coached girls soccer for 14 years, compiling an overall record of 208 wins, 93 losses, and 29 ties. Included in that record also are two second-place state finishes and one fourth-place state finish.
