# Highest Possible Composite Score on the American College Testing (ACT) Exam

Superintendent Cates made the following comments:

"Every high school student who prepares for college is aware of the importance placed on standardized college entrance exams, including the American College Test that we all know as the ACT. The highest possible composite score a student can earn on the ACT is a 36. Statistically, less than one-tenth of one-percent of students who take the ACT achieve the highest score.

Tonight, we will honor three District 211 students, two from William Fremd High School and one from Palatine High School, who have achieved this remarkable accomplishment. Twenty years ago, we began tracking students who have achieved a score of 36 on the ACT, and we now have a total of 122 students who have reached this outstanding achievement.

On behalf of the Board of Education and High School District 211, I would like to congratulate our three students. We have a certificate for each that Board President Mrs. Burke will present in just a moment. Our students will each be introduced by a sponsor who they have selected."

Superintendent Cates introduced William Fremd High School Mathematics Teacher Christopher Grattoni. Mr. Gratoni introduced and President Burke presented a certificate to William Fremd High School student Alice Chen for earning a 36, the highest possible composite score, on the October 2018 American College Test (ACT) examination.

Superintendent Cates introduced William Fremd High School Social Studies Teacher Jacqueline Dickens. Ms. Dickens introduced and President Burke presented a certificate to William Fremd High School student Eileen Peng for earning a 36, the highest possible composite score, on the October 2018 American College Test (ACT) examination.

Superintendent Cates introduced Palatine High School Mathematics Department Chair Craig Barnes. Mr. Barnes introduced and President Burke presented a certificate to Palatine High School student Ryan Tsau for earning a 36, the highest possible composite score, on the December 2018 American College Test (ACT) examination.

#### Highest Possible Composite Score on the Scholastic Aptitude Test (SAT)

Superintendent Cates made the following comments:

"We just heard about one college entrance exam and now I'd like to talk about the other, the Scholastic Aptitude Test, known as the SAT. The SAT is comprised of tests in mathematics, critical reading, and writing. Each year, the SAT is taken by 1.7 million students nationally, and of those, less than 300 achieve the highest possible score.

Tonight, I am pleased to say that we have a District 211 student from Fremd High School who has earned the highest possible score on the SAT.

On behalf of the Board of Education and High School District 211, congratulations on this outstanding achievement. Board President Mrs. Burke will present you with a certificate in a moment."

Superintendent Cates introduced William Fremd High School English Teacher Christina O'Donnell. Ms. O'Donnell introduced and President Burke presented a certificate to William Fremd High School student Lydia Hahm for earning the highest possible composite score on the June 2018 Scholastic Aptitude Test (SAT).

#### **Realtors Against Homelessness**

Superintendent Cates made the following comments:

"During the recession and the years following, a growing number of District 211 students had no regular, fixed, and adequate night-time residence. Upon hearing of the growing number of students, some remarkable people created an organization known as Realtors Against Homelessness, that we know as RAH, to take on the mission of raising funds to assist students across District 211 who themselves have no home. As realtors, this mission was personal to them. Their lives are committed to creating homes and even though they work for different companies, now they were united and committed to directing their efforts to serve students and their families who had lost their homes.

Through an annual fundraising event and partnership with the District 211 Foundation, since launching their mission in 2011, these wonderful people from RAH have raised more than \$270,000, with all of it benefiting homeless students in District 211. The work of the RAH committee has helped reduce stressors in the lives of many students who face extremely challenging circumstances so that these students can focus on their education and enjoy the many experiences our schools offer.

I would like to introduce the 10 members of the RAH Committee. When I call your name, please come to the Board table to receive the certificate of appreciation from Board of Education President Mucia Burke. On behalf of the Board of Education and all of High School District 211, I would like to extend a sincere thank you for all that you have done for so many young people."

Superintendent Cates introduced and President Burke presented certificates to these members of the Realtors Against Homelessness Committee whose fundraising work helps provide housing assistance, meals, utility payments, and athletic/activity fees that helps lessen the burden the growing number of homeless students within the District 211 boundaries face: RAH Committee Chair Cindy Eich from RE/MAX at Home, Gail Bergstrom from RE/MAX at Home, Nick Blesz from Century 21 – 1st Class Homes, Sandie Boxleitner Bobus from Coldwell Banker, Maureen Brand from RE/MAX Suburban Schaumburg, Randy Brush from Coldwell Banker Residential Brokerage, Marty Eich from RE/MAX at Home, and Maria Radwan from Baird & Warner Palatine.

Superintendent Cates made the following comments:

"Two other members of the RAH Committee could not join us tonight: Sue Gould from Berkshire Hathaway Homes Services Starck Real Estate and Basel Tarabein from RE/MAX at Home.

It is remarkable what the RAH Committee has done and the stories and testaments behind them truly leave one to be emotional, and I am going to contain that from you tonight. But, I give you my heartfelt appreciation for all that you do for our students. Thank you."

President Burke extended congratulations, on behalf of the Board of Education, to all of the athletes and students here tonight as well as to the RAH Committee members for all of their hard work and dedication.
