### **Those Who Excel**

Superintendent Cates made the following comments:

Schaumburg High School Special Education Teacher Alina Morelli Baima was honored with her "Those Who Excel" award in the Classroom Teacher category. Alina was recognized for her dedication and for working tirelessly to make sure her Schaumburg High School students rise to their maximum potential through the opportunities available to them. Beginning as a classroom mother, and progressing through as a chaperone, PTA member, and Booster Club president, she has served selflessly.

In her professional life as a realtor, she saw the effects of the economic downturn and the tragic hardships it was causing many of our families. She felt compelled to act and in conjunction with her role as District 211 Foundation Chair, she brought together a group of dedicated people to create "Realtors Against Homelessness." In the "Those Who Excel" Team category, Conant High School's Sophomore English Acceleration Team was recognized. Over the past two years, this team of educators has helped accelerate numerous students to be successful in Advanced Placement (AP) courses. By using test scores, freshman year grades, and attendance, students are identified who possess high levels of reading comprehension, yet have not qualified for accelerated English classes. Families are contacted and students are offered the opportunity to participate in AP classes that will appropriately challenge them. Many families that have participated in the program have remarked that they appreciated how the school found ways to support their child's education through new opportunities and the necessary supports to help them succeed.

Principal Julie Nowak had this to say, "The impact of this team extends far beyond one classroom experience as these students were taught skills to help them be accelerated learners for the rest of their lives."

I'd like to introduce the Sophomore English Acceleration Team and thank each of them for their role in the great program.

Gary Steiger began his career in District 211 30 years ago at William Fremd High School as a science teacher. After serving as an assistant principal at both Palatine and James B. Conant High Schools, he was named principal at Palatine High School in 2002. Over the years, he has seen his student population change dramatically and has responded to the needs of his students with staff training, successful initiatives improving overall school environment, and creating a community of teachers, staff, and parents who all work together collaboratively.
