A regular meeting of the Board of Education, Township High School District 211, Cook County, Illinois was held on September 20, 2018 at 7:30 p.m. in the G. A. McElroy Administration Center at 1750 South Roselle Road, Palatine, Illinois.

Highest Possible Composite Score on the American College Testing (ACT) Exam

Superintendent Cates made the following comments:

"Every high school student who prepares for college is aware of the emphasis placed on standardized college entrance exams, including the American College Test, or the ACT as it is called. The highest possible composite score a student can earn on the ACT is a 36. Statistically, less than one-tenth of one percent of students who take the ACT achieve the highest score.

Tonight, we recognize four students from William Fremd High School who have achieved this remarkable accomplishment. Twenty years ago, we began tracking students who have achieved a score of 36 on the ACT and with the addition of these four students, we now have 119 students who have accomplished this outstanding achievement.

On behalf of the Board of Education and High School District 211, I would like to congratulate our four students. We have a certificate for each student that Board President Mrs. Burke will present in a moment. Our students will each be introduced by a sponsor they have selected."

Superintendent Cates introduced William Fremd High School English Teacher Theresa Christensen. Ms. Christensen introduced and President Burke presented a certificate to William Fremd High School student Ayushi Balan for earning a 36, the highest possible composite score, on the June 2018 American College Test (ACT) examination.

Superintendent Cates introduced William Fremd High School World Language Teacher John Snyder. Mr. Snyder introduced and President Burke presented a certificate to William Fremd High School student Stella Chung for earning a 36, the highest possible composite score, on the July 2018 American College Test (ACT) examination.

Superintendent Cates introduced William Fremd High School Science Teacher Julie Zinger. Mrs. Zinger introduced and President Burke presented a certificate to William Fremd High School student Christina Hu for earning a 36, the highest possible composite score, on the July 2018 American College Test (ACT) examination.

Superintendent Cates introduced William Fremd High School Mathematics Teacher Christopher Grattoni. Mr. Grattoni introduced and President Burke presented a certificate to William Fremd High School student Nipun Velupally for earning a 36, the highest possible composite score, on the June 2018 American College Test (ACT) examination.
