A special meeting of the Board of Education, Township High School District 211, Cook County, Illinois was held on August 3, 2017 at 6:30 p.m. in the G. A. McElroy Administration Center at 1750 South Roselle Road, Palatine, Illinois.

President Burke led the Board of Education and the audience in the Pledge of Allegiance.

### **Citizens' Petitions and Appearances**

President Burke asked if there was anyone present, not on the agenda and who did not sign in on the speaker sign-in sheets, who wished to speak before the Board of Education.

Len Green addressed the Board regarding the Board's tasks for the budget for fiscal year 2018 and the teacher contract negotiations, the state's funding for schools, costs and matters that affect education, and interests of residents and taxpayers.

### **Appointment of New Board Member**

Mrs. Klimkowicz made a motion, seconded by Mr. Dombrowski, that the Board of Education appoint Steven Rosenblum to fill the vacancy created by the resignation of Lauanna Recker with said term to expire in April 2019.

Mrs. Burke made the following comments:

"With 16 applicants, the Board of Education was very pleased with the strong interest in the vacant seat. We received applications from a field of many qualified candidates and the ultimate decision to choose one candidate from among this deep pool of candidates was difficult. We are extremely fortunate to have such outstanding citizens within the communities served by District 211 who are willing to be involved in our education system."
