RESOLUTION AUTHORIZING THE ABATEMENT OF A PORTION OF THE TAXES HERETOFORE LEVIED BY TOWNSHIP HIGH SCHOOL DISTRICT NO. 211, COOK COUNTY, ILLINOIS

WHEREAS, the Board of Education (the "Board") of Township High School District No. 211, Cook County, Illinois (the "District"), by resolution adopted on December 13, 2018 (the "Resolution"), did provide for the levy of taxes; and

WHEREAS, on December 18, 2018, a duly certified copy of the Resolution and Certificate of Tax Levy were filed in the office of the County Clerk of Cook County, Illinois (the "County Clerk"); and

WHEREAS, since the adoption and filing of the Resolution, the Board has received a grant from the State of Illinois under the Property Tax Relief Grant program in the amount of \$1,284,516.64; and

WHEREAS, the Board wishes to modify and reduce its overall tax levy for tax year 2018 considering the receipt of funds under the Property Tax Relief Grant program; and

WHEREAS, it is necessary and in the best interests of the District that a part of the taxes heretofore levied be abated:

NOW, THEREFORE, Be It Resolved by the Board of Education of Township High School District No. 211, Cook County, Illinois, as follows:

Section 1. The tax levy for the year 2018 shall be abated by \$1,965,445 with the reduction in the levy to be made from the Educational and the Operations and Maintenance Funds only, as follows:
