Highest Possible Composite Score on the Scholastic Aptitude Test (SAT)

"Every high school student who prepares for college is aware of the importance placed on standardized college entrance exams, including the Scholastic Aptitude Test, known as the SAT. The SAT is comprised of tests in mathematics, critical reading, and writing. Each year, the SAT is taken by nearly two million students nationally, and of those, only about 300 achieve the highest possible score.

Tonight, I am pleased to say that we have a District 211 student from Fremd High School who has earned the highest possible score on the SAT.

On behalf of the Board of Education and High School District 211, I'd like to congratulate our student on this outstanding achievement. Board President Mr. LeFevre will present our student with a certificate in a moment."
