



Welcome To the Popular Annual Financial Report



Township High School District 211 serves 12,000 students from the communities of Hoffman Estates, Inverness, Palatine, Schaumburg, and portions of Arlington Heights, Elk Grove Village, Hanover Park, Rolling Meadows, Roselle, South Barrington, and Streamwood in the Northwest suburbs of Chicago.

District 211's five high schools serve grades 9-12: James B. Conant, William Fremd, Hoffman Estates, Palatine, and Schaumburg High Schools. Each school has earned full recognition status by the State Superintendent of Schools of Illinois. All five high schools have received the United States Department of Education's Blue Ribbon Secondary Schools Award, and Palatine and Fremd High Schools have been recognized twice. District 211 also has two alternative schools, District 211 North Campus and Higgins Education Center, which serve approximately 175 students.



FINANCIAL POSITION

SUMMARIZED FINANCIAL REPORTS

The PAFR contains summarized highlights of district finances, with key data taken from the audited financial statements in the District's Annual Comprehensive Financial Report (ACFR) for the fiscal year ending June 30, 2023. This information is presented in a non-GAAP format.

STATEMENT OF NET POSITION

The Statement of Net Position provides a snapshot of the District's finances at the close of the fiscal year. Simply stated, it is total assets (what the District owns) minus total liabilities (what the District owes), plus and minus deferred outflows and inflows of resources (resources to be consumed or acquired in a future period). The difference between these amounts is the net position and represents the District's equity.

The Net Position is further broken down into three components:

- Net investment in capital assets represents the District's ownership of capital assets such as land, buildings, site improvements, vehicles, and equipment, less outstanding related debt.
- Restricted net position represents net assets that can only be used for a specific purpose as designate by law. These purposes include pension funding, capital projects, debt repayment, operations and maintenance and student transportation.
- Unrestricted net position represents amounts that may be used for any general legal purpose of the District.

The District's overall net position increased favorably from the prior year by \$17.5 million.

Note: The long-term liabilities and negative unrestricted net position is due to the recording of Other Post-Employment Benefits under GASB 74, as implemented July 1, 2017. This GASB required the District to record its share of the Teachers' Health Insurance System outstanding obligations. This liability is for reporting only and does not impact the District's ability to meet its obligations in the future.

OUTSTANDING DEBT

District 211 is debt-free and committed to maintaining this status for as long as economics allow. The District completed its fifth straight year with no outstanding bonded debt and has no capital lease obligations. Operating debt-free signifies the District can self-fund its day-to-day operations and its capital project needs. This translates to lower property taxes for the residents and businesses within the District's boundaries.

FUTURE FINANCIAL OUTLOOK

District 211 is in a solid financial position to accomplish its educational and operational strategic goals over the next five years. Through prudent financial management over the past decade, the District has funded all academic and operational initiatives, paid off its debt, and accumulated appropriate levels of reserves (savings). Expenses incurred as a result of the COVID-19 pandemic were mostly offset by emergency federal funding. Reserve balances increased slightly this year due to higher than anticipated interest earnings and replacement taxes. Fund balances are projected to decline



over the next five years to fund capital project requirements; however, these balances remain sufficient for the District to weather unpredictable changes in the timing of revenue receipts such as the current delay in the processing/collection of the second installment of real estate taxes, or new state mandates.

REVENUES HOW IS DISTRICT 211 FUNDED?


The District recognized \$347.9 million of revenue in 2023. The majority of the District's revenue comes from local property taxes. Through sound financial management, the District has been able to limit the increase in the property tax burden to the local community residents and businesses. The 2022 levy reflects an increase of 3.8% over the prior year levy, while the consumer price index rose 7% during the applicable period. Property tax refunds directly offset revenue collected and are a significant revenue loss to the District. These refunds put additional financial pressure on the District. A new state laws allows for a portion of these refunds to be re-levied across all taxpayers. The District abated (waived) this levy for as it relates to the 2022 tax year.


During fiscal 2023, over 20% of the District's revenue was from Operating Grants and Contributions from the State of Illinois and the federal government. Approximately 71% of this revenue recognized was considered an "onbehalf" payment for pension benefits, funded directly by the State to the pension system. Other grants include funding for services and transportation for students with special needs, the school lunch and breakfast program, services for economically disadvantage students, and various other vocational and educational programs.

Charges for Services represents 2.9% of total revenue and consists of fees charged to students and others for summer school and evening programs, facility rentals, driver's education and other special programs. Instructional fees were waived for the 2022-2023 school year by the Board of Education, and no meal fees were collected this year due to the national pandemic. The State Formula Aid and Other Revenue contribute 3.6% and 1.7% to the District's total revenue, respectively.

EXPENSES

HOW DOES DISTRICT 211 SPEND ITS FUNDS?

Total expenses for the year ended June 30, 2023 were \$330.0 million. The graph below is a summary of how Township High School District 211 spend its funds across specific program areas.

Funds spent on Instruction include salaries and benefits for classroom personnel and the materials and services required to support instructional programs. These costs total approximately two-thirds of the District's total expenses.

Pupil and Instructional Services expenses include personnel costs and supplies for guidance counselors, social workers, school nurses, psychologists, speech pathologists and other support services who assist the students with needs outside the classroom.

Administration and Business Services represent costs to provide central support for the District such as accounting, budgeting, planning, food service and purchasing, as well as school administration.

Operations and Maintenance costs are monies spent to maintain the eight buildings and surrounding grounds throughout the District. Costs include salaries and benefits, custodial supplies, utilities, service agreements and capital outlay. For the 2022-2023 fiscal year, major capital outlay in this area included renovation to multiple parking lots, locker room renovations, washroom renovations, Public Address system improvements, carpet replacement, roof replacement, approved life safety projects and classroom renovations at multiple schools.


Transportation expenses include costs to operate and maintain the District's fleet of approximately 160 school buses and 40 vans. Eleven new buses were purchased during the 2022-2023 fiscal year as replacements for aging equipment. All of the buses purchased were propane-fueled which is a cleaner, more cost-effective fuel alternative.

Other expenses include salary, benefits, supplies and purchased services for the technology, publications and human resource departments.




DISTRICT-WIDE EXPENSES BY FUNCTION 2023

Capital Projects







BUILDING IMPROVEMENTS

Township High School District 211 operates and maintains eight buildings across the District and prepares an annual Capital Projects budget to allocate funds for completion of necessary building improvements. Capital improvement projects were identified and prioritized through the 2021 Strategic Plans, 10-year capital improvement plan, and routine maintenance and replacement schedules.

During the 2022-2023 fiscal year, the following facility improvement projects were in various stages of completion across the District at a cost of \$17.9 million in total. All facility improvement projects were funded through the District's existing operating reserves.

- Renovation of the locker rooms at Conant High School
- Completion of wash room renovations at Fremd and Palatine High Schools
- Renovation of the Culinary Arts lab at Fremd High School
- Public Address system improvements at Hoffman Estates and Fremd High Schools
- Paving work across all schools
- Air handling equipment additions to previously uncooled areas at Conant High School and Palatine High School

The Illinois School Code requires school districts to perform a Fire Prevention and Life Safety Survey at a minimum of once every ten years. Projects identified on the Survey were reviewed and approved by the Regional Office of Education and the Illinois State Board of Education. During summer 2023, the District completed the remaining projects approved on the 2019 Survey including mechanical upgrades at Conant High School and phase II of demountable wall replacements at Palatine High School.



FUTURE FACILITY IMPROVEMENT PLANNING

The District's strategic plan calls for ongoing safety and security improvements, a facility improvement study and continuation of the current ten-year capital facility improvements. The Board of Education also approved planning costs to review possible improvements to student auditoriums and improvements to public address systems as the primary communication tool within our schools. Barring no major legislative action that would negatively impact the financial status of the District, the strategic plan prioritizes the use of current reserve funds and future budget surpluses to fund facility improvement projects without issuance of bonds.





Educational Update

Hundreds attend First Generation College Event

District 211's First Generation College Workshop was held at Palatine High School October 17, marking the event's first return to an all in-person event since the COVID-19 pandemic.

Counselors and administrators from across District 211, as well as representatives from Harper College, the Illinois Student Assistance Commision, and other local colleges, discussed topics ranging from the college application process to applying for financial aid. The workshop is focused on juniors and seniors who may be the first in their family to navigate the collegiate application process.

The First Generation College Workshop is part of a series of events hosted by District



211 to help prepare all students for postsecondary life. Other events include District 211 College Night, the Directions College and Career Fair for those with special needs, and the Senior Job Fair for students planning to launch their career immediately following high school graduation.

Project Excel creates success stories, leaders at Palatine High School



Since its inception in 2008, Project Excel at Palatine High School has focused on a singular goal: postsecondary success in college and careers for the students in the program.

Along the way, though, it accrued an impressive statistic: Typically, 100 percent of its students – nearly all of them the first in their family to go to college – are accepted to college.

"These students come to us sometimes skeptical of the program, but always leave ready to make big things happen," said Alonso Ramirez, the program's lead teacher and adviser. "Our mission is to believe in them more than they believe in themselves, and to inspire them so they know anything is possible."

The students, Ramirez says, are placed in the program in part for their scholastic potential

but also because of their hard work, grit and determination.

Project Excel students attend college field trips, receive additional help on college applications, and delve deep into discussions on future opportunities. Those in charge, in turn, make sure the students are supported in their goals, and positioned to reach their full potential.

Principal Tony Medina says Project Excel helps level the playing field, making sure all are able to see the opportunities and experiences for college and career readiness once they graduate.

Project Excel is a program used within multiple District 211 schools as an opportunity to build even greater successes for firstgeneration students who may just need a little more support.

Hoffman Estates High School Celebrates





It's a golden year for Hoffman Estates High School.

The school, the last large high school added to District 211, is celebrating its 50th anniversary this school year. The celebration kicked off in August with school group performances, continued with a significant turnout of alumni at homecoming in September, and rolled into October with a school-wide birthday celebration complete with cake.

CBS 2 Director of Engineering Tom Schnecke, one of the school's first alums, turned out for homecoming and brought his team with him – interviewing and filming students and staff and giving the band, athletic teams and cheerleaders time in the spotlight.

The school opened its doors in October 1973 with freshmen and sophomores; its first graduation was held in 1976. The school has marked numerous achievements over the last half-century, receiving the U.S. Department of Education Blue Ribbon Award of Excellence and receiving an "Exemplary" rating two years in a row on the State of Illinois School Report Card.

Annual Architectural Design Competition

The 211 District Board Room was full of excitement, displays and determination in November, as 10 students from all five high schools presented their hard work at the annual Architectural Design Competition. Parents and staff gathered to applaud the home designs created by the students as they competed for the opportunity of a lifetime: the chance for their home design to be built by District 211 Building Construction students.

A panel of judges consisting of professionals from different aspects of architecture and construction examined the students' designs and responded to presentations of their work.

"I stayed after school for about a month in order to take my project from a vision to the completed design," Schaumburg High School Junior Lorena Romaniz said.

Some students attributed their interest in creating the designs to video games that require design and building and talked about the availability of free design software.

"This competition is an excellent opportunity presented to students from the District," Fremd Applied Technology teacher Mike Crosse said. "This program leads to truly authentic designs and separates District 211 graduates from others."

Judges gave both supportive compliments and constructive criticism before deliberating.

"This is an amazing opportunity to showcase a career pathway from design to construction," Director of College and Career Readiness Michele Napier said. "This hard work is proof of how students have opportunities to explore their interests while preparing for their first steps toward their future careers. We are extremely appreciative of all the community members who stand next to us as we begin to build, design and sell these student homes, all while mentoring and preparing students for their futures."

Hoffman Estates High School sophomore **Nicole Pelzman** took first place for her home design – the first time the competition has gone to a Hoffman Estates student. The home now will be built and sold in the community through the Building Construction program, whose students work alongside teachers and industry experts to complete construction.
