## Student Athletic Trainer Club Cart Procedures

In order to provide adequate and timely coverage to several athletic events, District 211 Athletic Training departments allow student athletic trainers to utilize club carts. The procedures listed below are to ensure safe operation of the club carts by student athletic trainers.

1. Before operating a club cart, the head athletic trainer of each school will provide an orientation to student athletic trainers on how to safely operate a club cart.
2. Student athletic trainers under the age of 16, or those who do not possess a valid driver's license will not be allowed to operate a club cart.
3. A copy of a valid Illinois driver's license will be kept on file for each student athletic trainer eligible to drive a club cart.
4. Student Athletic trainers must adhere to Illinois Rules of the Road and safe driving practices when operating a club cart.
5. Student athletic trainers (drivers and passengers) must always wear a seat belt while riding in a club cart.
6. The club cart is to be used for athletic training purposes only, and must remain on school grounds at all times.
7. Passenger capacity must be limited to the number of seats provided in the vehicle.
8. No texting or operating cell phones while in a club cart, regardless if you are the driver or passenger.
9. Student athletic trainers may not operate a club cart while taking any medications.
10. Student athletic trainers may not drive with gas pedal fully pushed down all the way.
11. Student athletic trainers are not allowed to drive on wet, icy, snow covered or uneven surfaces/fields.
12. Failure to operate the club cart in a safe manner will result in immediate suspension of a student's driving privileges, per the Head Athletic Trainer's discretion.

I/we understand that if I/we do not sign this release, then my child will not be permitted to operate the District 211 club cart.
