

Dear Students and Families of the Class of 2025:

The <u>Free Application for Federal Student Aid (FAFSA)</u> is now available. Completion of the FAFSA, <u>Alternative Application</u>, or NonParticipation Form will fulfill the graduation requirement in Illinois.

Students who are unable to complete the FAFSA or Alternative Application or who elect to waive FAFSA completion must complete and submit the <u>Nonparticipation Form</u> online to meet the Illinois **graduation requirement**.

To support our families with this process, we are offering financial aid completion workshops at all our schools. These workshops will provide guided, step-by-step support. Representatives from the Illinois Student Assistance Commission (<u>ISAC</u>) will be available to assist students and families. We encourage students and parents/guardians to attend any of the workshops below.

## PREPARE FOR THE WORKSHOP

For ISAC representatives to provide the best support, families are encouraged to prepare the following information prior to the workshop:

1. Both student and parent/guardian(s) must create their own FSA ID accounts prior to attending a workshop. Click <u>here</u> for the FSA ID website.

If you attend a workshop without an FSA ID created, you will **not** be able to begin the FAFSA process. Families who have a FSA ID but have not received verification will **not** be able to complete the entire application.

- 2. Students and parent/guardian(s) are required to have their social security number (SSN) to complete the <u>FAFSA</u>.
  - 1. If a parent/guardian(s) does not have a SSN, they can still complete the FAFSA.
  - 2. If a student does not have an SSN, they may be eligible to complete the <u>Alternative Application</u>.
- 3. If possible, please bring your own electronic device; laptops are recommended. Schools will have extra computers available for families to access if needed.
- 4. Please review the <u>recommended list of items</u> to bring to the workshop.
